SHARED CLEAN ENERGY FACILITY SUBSCRIBER RIDER

AVAILABILITY AND APPLICABILITY: This Rider provides the details of the Subscriber related provisions of the Shared Clean Energy Facility ("SCEF") program consistent with Section 7 of Public Act 18-50, *An Act Concerning Connecticut's Energy Future,* Section 3 of Public Act 19-35, *An Act Concerning a Green Economy and Environmental Protection,* Section 1 of Public Act 22-14, *An Act Concerning Clean Energy Tariff Programs,* and Section 25 of Public Act 23-102, *An Act Strengthening Protections for Connecticut's Consumers of Energy* ("the Acts") as codified in §16-244z of the Connecticut General Statutes and as approved by the Public Utilities Regulatory Authority ("PURA").

SUBSCRIBER ELIGIBILITY: Each SCEF must have at least ten (10) Subscribers located within the Company's Connecticut territory. Subscribers are limited to the following classes of customers: (1) Low-income, (2) Moderate-Income, (3) Low Income Service Organizations, (4) Affordable Housing Landlords, Entities and Facilities (5) Small Business Customers, (6) State or Municipal Customers, (7) Commercial Customers; and (8) Residential Customers, other than Low and Moderate Income (LMI) who rent/lease a property or own a property where on-site solar cannot be installed. Additional details regarding the enrollment process and credits is contained in the Subscriber Terms and Conditions.

In order to qualify for payments pursuant to this Rider, the participant(s) of this program must comply with this rider and the Subscriber Terms and Conditions. Enrollment in this program shall be capped at the total combined capacity of all selected SCEFs.

DEFINITIONS: As used throughout this Rider, capitalized terms used shall have the meanings set forth in the Subscriber Terms and Conditions.

APPLICATION: A Customer may become a Subscriber through one of two methods as described in the Terms and Conditions: 1) Company administered identification and enrollment process ("EDC-Administered Identification and Enrollment Process") or 2) voluntary enrollment ("Voluntary Enrollment"). The Company will enroll Customers as Subscribers using the Subscription Summary Form.

Under the SCEF Subscriber EDC-Administered Identification and Enrollment Process, the Company will identify customers meeting the eligibility requirements and enroll certain customers as Subscribers for each SCEF. As specified in the SCEF Program Manual, a percentage of each SCEF project's capacity will be allocated to Subscribers through an EDC-Administered Identification and Enrollment Process. Customers that are identified as eligible Subscribers will be provided a Subscription Summary Form detailing the program and how they may opt out of the program.

Under Voluntary Enrollment, as specified in the SCEF Program Manual, a percentage of each SCEF project's capacity is reserved for voluntary enrollment which provides Subscribers the opportunity to opt into the SCEF program by notifying the Company of their eligibility. The Company will enroll voluntary Subscribers in the program if it is determined they are eligible and if sufficient SCEF capacity is available.

Acceptance under this Rider is subject to the acceptance by the Company, DEEP, and certification by the Subscriber that they will comply with all provisions in the Rider, including the Subscriber Terms and Conditions.

SUBSCRIBER PAYMENTS: Credits are delivered by the Company as a fixed monthly Credit to a Subscriber through the Subscriber's electric bill. The EDC will credit the Subscriber based on that Subscriber's estimated annual consumption, as determined at the time of enrollment, and divide the estimated annual consumption by twelve (12) months and multiply that amount by \$0.025/kWh, which will result in a fixed monthly monetary Credit.

Additional payment information is found in the Subscriber Terms and Conditions.

TERM: Once enrolled, a Subscriber will maintain that Subscription, as long as that Subscriber remains in service with the Company, for a maximum term of 20 years from the in-service date of the SCEF, at which time, Subscriber credits will end.

Additional details and requirements under this Rider are included in the Subscriber Terms and Conditions, which is incorporated herein by reference.
