



Business RATES

Our commercial/industrial rates are for non-residential use. Condominium and cooperative common areas may take service on a commercial rate, if qualified.

02 General

This rate is for commercial and industrial customers with a load that is greater than 10 kW for three consecutive billing months, but not greater than 100 kW in each of the 12 consecutive billing months.

06 General Non-Demand

This rate is for commercial and industrial customers with a load that does not exceed 10 kW in any three consecutive billing months.

51 Optional General Time-of-Use – Non-Demand**

This rate is for commercial and industrial customers with a load that is less than 10 kW for any three consecutive billing months.

52 Optional General Time-of-Use**

This rate is for commercial and industrial customers with a load that is less than 100 kW in each of 12 consecutive months.

62 Large General Time-of-Use – Secondary Service**

This rate is for commercial and industrial customers with a load that is greater than 100 kW for at least 12 consecutive billing months.

70 Large General Time-of-Use** – 13.8 kV Service**

This rate is for commercial and industrial customers with a load that is greater than 100 kW for at least 12 consecutive billing months.

**For rates that have three time-of-use billing periods, Peak Load is from 9 a.m. to 6 p.m., Monday through Friday during Eastern Daylight Savings Time. During Eastern Standard Time, Peak Load is from 4 p.m. to 9 p.m., Monday through Friday. For both Eastern Daylight Savings Time and Eastern Standard Time, Low Load B is from 10 p.m. to 7 a.m., Monday through Friday and all hours on the weekend. Low Load A includes all hours not included in Peak Load or Low Load B.

For rates with two time-of-use billing periods, Peak Load is from 9 a.m. to 6 p.m., Monday through Friday, during Eastern Daylight Savings Time. During Eastern Standard Time, Peak Load is from 4 p.m. to 9 p.m., Monday through Friday. Low Load includes all hours not included in Peak Load.

Eversource offers different rates to best meet your needs. Which rate is best for you depends on a number of factors, including whether you use electricity for heating, meet discount rate guidelines, or use electricity during off-peak hours.

Residential RATES

Our residential rates are for domestic use in single private dwellings, individual apartments or in a residential condominium. Condominium and cooperative common areas may take service on residential rates or any lower commercial rate, if qualified.

01 Residential Non-Heating

This basic, general use rate is for residential customers in a single, private dwelling, an individual apartment or a residential condominium. The principal means of heating cannot be permanently installed electric space heating.

04 Residential Space Heating

This basic, general use rate is for residential customers in a single, private dwelling, an individual apartment or a residential condominium where electric space heating is the principal means of heating.

05 Residential Assistance – without electric heat

This discount rate is for residential customers who receive certain government means-tested benefits or fuel assistance. This rate is available only to qualified customers in individual private dwellings or individual apartments. A 24.9 percent discount will be applied to the total bill amount.

07 Residential Assistance – Heating

This discount rate is for residential customers who receive certain government means-tested benefits or fuel assistance. The rate is available only to qualified customers in a single, private dwelling, an individual apartment or residential condominium where the principal means of heating is permanently installed electric space heating equipment. A 24.8 percent discount will be applied to the total bill amount.

10 Optional Residential Space Heating Time-of-Use**

This time-of-use rate is for residential customers in a single, private dwelling, an individual apartment or residential condominium where the principal means of heating is permanently installed electric space heating.

48 Optional Residential Time-of-Use**

This time-of-use rate is for residential customers in a single, private dwelling, an individual apartment or a residential condominium where the principal means of heating is not permanently installed electric space heating.
