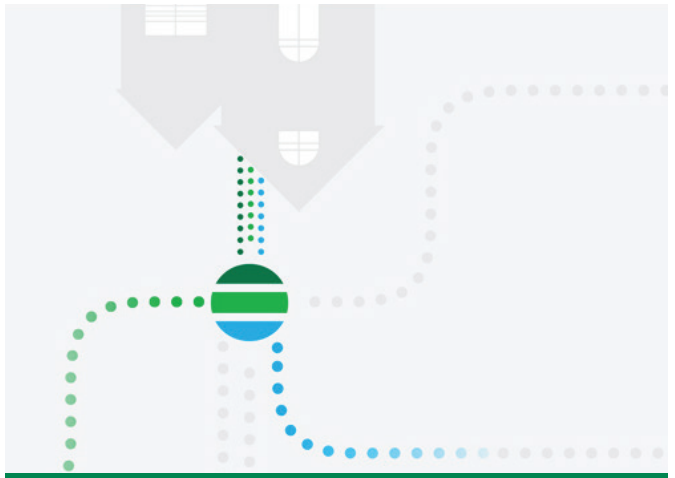

RATES

Our commercial/industrial rates are for non-residential use. Condominium and cooperative common areas may take service on a lower commercial rate, if qualified.

"Annual use" means your total electricity use in the four billing months between June 1 and Sept. 30 is less than your total use for the other eight billing months of the calendar year.

"Seasonal use" means your total electricity use in the four billing months between June 1 and Sept. 30 is more than your total use for the other eight billing months of the calendar year.

23 General – Seasonal Optional

This seasonal use rate is for commercial and industrial customers with a load that does not exceed 100 kW in each of 12 consecutive billing months and who agree to pay a minimum of 50 kW of demand each month.

24 Large General Time-of-Use**

This seasonal use rate is for commercial and industrial customers with a load that exceeds 500 kW in each of 12 consecutive billing months.

31 Optional General Seasonal Time-of-Use**

This rate is for commercial and industrial customers with a load that is less than or equal to 100 kW with seasonal use.

33 General Annual

This general, annual use rate is for commercial and industrial customers with a load that does not exceed 100 kW in each of 12 consecutive billing months.

35 General Seasonal

This general, seasonal use rate is for commercial and industrial customers with a load that does not exceed 100 kW in each of 12 consecutive billing months.

55 Optional General Time-of-Use**

This rate is for commercial and industrial customers with a load that is less than or equal to 100 kW. Usage must be annual.

84 Medium General Time-of-Use**

This rate is for commercial and industrial customers with a load that is in excess of 100 kWh but not greater than 500 kW for at least 12 consecutive months. Usage must be annual.

**For rates that have three time-of-use billing periods, Peak Load is from 9 a.m. to 6 p.m., Monday through Friday during Eastern Daylight Savings Time. During Eastern Standard Time, Peak Load is from 4 p.m. to 9 p.m., Monday through Friday. For both Eastern Daylight Savings Time and Eastern Standard Time, Low Load B is from 10 p.m. to 7 a.m., Monday through Friday and all hours on the weekend. Low Load A includes all hours not included in Peak Load or Low Load B.

For rates with two time-of-use billing periods, Peak Load is from 9 a.m. to 6 p.m., Monday through Friday, during Eastern Daylight Savings Time. During Eastern Standard Time, Peak Load is from 4 p.m. to 9 p.m., Monday through Friday. Low Load includes all hours not included in Peak Load.

Eversource offers different rates to best meet your needs. Which rate is best for you depends on a number of factors, including whether you use electricity for heating, meet discount rate guidelines, or use electricity during off-peak hours.

Residential RATES

Our residential rates are for domestic use in single private dwellings, individual apartments or in a residential condominium. Condominium and cooperative common areas may take service on residential rate or any lower commercial rate, if qualified.

"Annual use" means your total electricity use in the four billing months between June 1 and Sept. 30 is less than your total use for the other eight billing months of the calendar year.

"Seasonal use" means your total electricity use in the four billing months between June 1 and Sept. 30 is more than your total use for the other eight billing months of the calendar year.

30 Residential Assistance – Annual (without electric heat)

This discount rate is for residential customers who receive certain government means-tested benefits or fuel assistance and have annual usage. A 22.5 percent discount will be applied to the total bill amount.

32 Residential Non-Heating – Annual

This basic, general use rate is for residential customers with annual use.

37 Residential Assistance – Seasonal (without electric heat)

This discount rate is for seasonal use residential customers who receive certain government means-tested benefits or fuel assistance. A 27.1 percent discount will be applied to the total bill amount.

38 Residential Assistance – Seasonal Optional

This discount rate is for seasonal use residential customers who receive certain government means-tested benefits or fuel assistance. Customers also agree to pay a minimum of \$6.39 per month. A 22.5 percent discount will be applied to the total bill amount.

39 Optional Residential Time-of-Use**

This time-of-use rate is available for residential customers. The rate might benefit customers who use most of their electricity during off-peak hours. However, the cost increases if use is during all other hours.

42 Residential Space Heating Assistance

This heating rate is for residential customers with certain government means-tested benefits or fuel assistance where the principal means of heating is permanently installed electric space heating. A 19.7 percent discount will be applied to the total bill amount.

66 Residential Non-Heating Seasonal

This basic, general use rate is for residential customers with seasonal use.

68 Residential Non-Heating – Seasonal Optional

This rate is for residential customers whose usage is seasonal. Customers also agree to pay a minimum of \$10.93 per month.

86 Residential Space Heating

This heating rate is for residential customers where the principal means of heating is permanently installed electric space heating.
