How do I apply?

Contact the agency which administers this program in your city or town – a list appears below and continues on the back of this brochure. Please be prepared to provide proof of income and your most recent heating bill. Please note, you need to apply to receive Fuel Assistance each winter. If you have already applied for the upcoming heating season you do not need to apply again.

How does the program work?

When you apply, the agency handling the energy assistance program for your city or town will notify Eversource of your eligibility. If your heating bill exceeds the amount of assistance received, please call Eversource to discuss a payment arrangement for the balance.

What if I am not eligible?

Households of limited income who may not be eligible for Fuel Assistance can contact the Good Neighbor Energy Fund at 800-334-3047, beginning December 1, 2017. Additional assistance may be available through local fuel funds, city or town halls, churches, and other charitable organizations.
