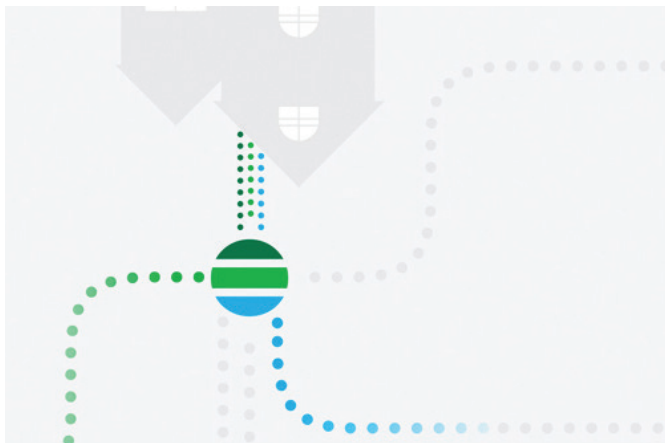


Gas Rates

Business Rates

Our business rates are for non-residential use, and have been approved by the Massachusetts Department of Public Utilities (DPU). For rate information visit [Eversource.com](https://www.eversource.com).

G40 Low Annual/High Winter

This rate is for non-residential customers whose annual usage is less than 5,000 therms and whose peak period usage is greater than or equal to 70 percent of annual use.

G41 Medium Annual/High Winter

This rate is for non-residential customers whose annual usage is between 5,000 and 39,999 therms and whose peak period usage is greater than or equal to 70 percent of annual use.

G42 High Annual/High Winter

This rate is for non-residential customers whose annual usage is between 40,000 and 249,999 therms and whose peak period usage is greater than or equal to 70 percent of annual use.

G43 Extra High Annual/High Winter

This rate is for non-residential customers whose annual usage is 250,000 therms or more and whose peak period usage is greater than or equal to 70 percent of annual use.

G50 Low Annual/Low Winter

This rate is for non-residential customers whose annual usage is less than 5,000 therms of gas and whose peak period usage is less than 70 percent of annual use.

G51 Medium Annual/Low Winter

This rate is for non-residential customers whose annual usage is between 5,000 and 39,999 therms of gas and whose peak period usage is less than 70 percent of annual use.

G52 High Annual/Low Winter

This rate is for non-residential customers whose annual usage is between 40,000 and 249,999 therms and whose peak period usage is less than 70 percent of annual use.

G53 Extra High Annual/Low Winter

This rate is for non-residential customers whose annual usage is 250,000 therms or more and whose peak period usage is less than 70 percent of annual use.

L60 Outdoor Lighting

This rate is available for customers with outdoor gas lighting where a standard gas light is attached to the existing distribution system, and when it is not feasible to meter gas for such lighting along with other gas used on the premises and bill the same under the rate in effect for all other service. All such installations shall be on private property.

Eversource offers different rates to best meet your needs. Which rate is best for you depends on a number of factors, including whether you use gas for heating, or meet discount rate guidelines.

Residential RATES

Our residential rates are for domestic use in single private dwellings, individual apartments or in a residential condominium. For rate information visit [Eversource.com](https://www.eversource.com).

R1 Residential Non-Heating

This rate is for residential customers in individual private dwellings and individual apartments including condominiums and their facilities.

R2 Residential Assistance Non-Heating

This discount rate is for residential customers who receive certain government means-tested benefits or fuel assistance. This rate is available only to qualified customers at single locations for all domestic purposes, except for resale, in individual private dwellings and individual apartments. A 25% discount will be applied to the total bill amount.

R3 Residential Heating

This rate is for residential customers in individual private dwellings and individual apartments including condominiums and their facilities where such residences are heated exclusively through permanently installed space heating equipment.

R4 Residential Assistance Heating

This discount rate is for residential customers who receive certain government means-tested benefits or fuel assistance. This rate is available to qualified customers in individual private dwellings and individual apartments including condominiums and their facilities where such residences are heated exclusively through permanently installed space heating equipment. A 25% discount will be applied to the total bill amount.
