


Electric RATES

Residential RATES

Our residential rates are for domestic use in single private dwellings, individual apartments or in a residential condominium. Condominium and cooperative common areas may take service on residential rates or any lower commercial rate, if qualified.

R-1 Residential

This rate is available to all domestic uses in a single private dwelling, in an individual apartment or in a residential condominium in which the principal means of heating the premises is not provided by permanently installed electric space heating equipment.

R-2 Residential Assistance

This rate is available to all domestic uses in a single private dwelling, in an individual apartment or in a residential condominium in which the principal means of heating the premises is not provided by permanently installed electric space heating equipment. To be eligible for this rate, customers need to receive certain means-tested government benefits or fuel assistance. A 42% discount will be applied to the total bill amount.

R-3 Residential Space Heating

This rate is available to all domestic uses in a single private dwelling, in an individual apartment or in a residential condominium in which the principal means of heating the premises is provided by permanently installed electric space heating equipment.

R-4 Residential Space Heating Assistance

This rate is available to all domestic uses in a single private dwelling, in an individual apartment or in a residential condominium in which the principal means of heating the premises is provided by permanently installed electric space heating equipment. A 42% discount will be applied to the total bill amount.

Eversource offers different rates to best meet your needs. Which rate is best for you depends on a number of factors, including whether you use electricity for heating, meet discount rate guidelines, or use electricity during off-peak hours.

Business RATES

Our business rates are for non-residential use. Condominium and cooperative common areas may take service on a small general service rate, if qualified.

GREATER BOSTON SERVICE AREA

G-1 Non Demand Small General Service (Non Demand Price Option)

This rate is for non-residential customers where the service voltage is less than 14,000 volts and the monthly demand does not exceed an average of 100 kW for 12 consecutive months. All new customers will be assigned the Non-Demand Price Option unless otherwise requested by the customer. Demand meters will be installed for all new customers.

G-1 Demand Small General Service (Demand Price Option)

This rate is for non-residential customers where the service voltage is less than 14,000 volts and the monthly demand does not exceed an average of 100 kW for 12 consecutive months. Customers with demand that does not exceed an average of 10 kW for 12 consecutive months may not elect the Demand Price Option. Demand meters will be installed for all new customers.

G-2 Medium General Service

This rate is for customers where the service voltage is less than 14,000 volts and the monthly demand is greater than an average of 100 kW for 12 months.

G-3 Large General Service

This rate is for customers where the service voltage is 14,000 volts or more and the Customer furnishes, installs, owns and maintains at their expense all protective devices, transformers and other equipment required by the Company. This rate has peak and off-peak periods.

CAMBRIDGE SERVICE AREA

G-1 Small General Service

This rate is for non-residential customers where the service voltage is less than 13,800 volts and the demand does not exceed an average of 100 kW for 12 consecutive billing months.

G-2 Medium General Service

This rate is for customers where the service voltage is less than 13,800 volts and the demand exceeds an average of 100 kilowatts for at least 12 consecutive billing months.

G-3 Large General Service

This rate is for customers with a load that is greater than an average of 100 kW for at least 12 consecutive billing months and the service voltage is 13,800 volts or higher.

SOUTH SHORE, CAPE COD & MARTHA'S VINEYARD SERVICE AREA

G-1 Small General Service

This rate is for non-residential customers with a load that does not exceed an average 100 kW for 12 consecutive billing months. Demand meters will be installed for all new customers.

G-2 Medium General Service

This rate is for customers with a load that is greater than an average of 100 kW but less than an average of 500 kW for 12 consecutive billing months.

G-3 Large General Service

This rate is for customers with a load that is greater than an average of 500 kW for 12 consecutive billing months.
