Your Energy Disclosure Label and Basic Service Prices

This label is updated quarterly and provides you information about electricity you are buying.

In 2024, for Residential and Small Commercial/Industrial customers, Basic Service pricing will be fixed from Jan. 1 to July 31 and then Aug. 1 to Jan. 31, 2025. For Large Commercial/Industrial customers pricing it will be fixed from Jan. 1 to April 30; May 1 to July 31; Aug. 1 to Oct. 31; and Nov. 1 to Jan. 31, 2025.

Please note, Basic Service prices are for the generation/electric supply portion of your bill and do not include regulated charges for customer service and delivery.

**Power Sources:**

The electricity you consume comes from the New England power grid and is generated by a variety of power plants throughout the region. ### Emissions:

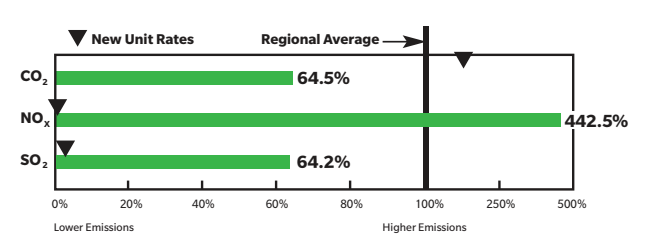
Emissions for each of the pollutants listed are represented as a percent of the regional average emission rate. Arrows in the illustration to the right represent the emission rate from a hypothetical new generation facility.

**Carbon Dioxide (CO<sub>2</sub>)** is released when fossil fuels are burned. Carbon dioxide is a greenhouse gas and a major contributor to global warming.

**Nitrogen Oxides (NO<sub>x</sub>)** form when fossil fuels and biomass are burned at high temperatures. They contribute to acid rain and ground-level ozone (or smog). They may cause respiratory illness in children with frequent high exposure. It also contributes to oxygen deprivation of lakes and coastal waters, which is destructive to fish and other animal life.

**Sulfur Dioxide (SO<sub>2</sub>)** is formed when fuels containing sulfur are burned – primarily coal and oil. Major health effects associated with Sulfur Dioxide include asthma, respiratory illness, and aggravation of existing cardiovascular disease. It combines with water and oxygen in the air to form acid rain – raising the acid level of lakes and streams and accelerating the decay of buildings and monuments.
