BOSTON (March 18, 2021) – The Board of Directors of NSTAR Electric Company, a wholly-owned subsidiary of Eversource Energy, announced the declaration of the following preferred stock dividends payable May 1, 2021 to holders of record as of April 9, 2021:

- A quarterly dividend of \$1.0625 per share on NSTAR Electric Company’s cumulative preferred stock, 4.25% series; and
- A quarterly dividend of \$1.195 per share on NSTAR Electric Company’s cumulative preferred stock, 4.78% series.
