

Summary of Business Gas Rates (CT)

Last Updated: April 1, 2022

The following rates are available to customers and have been approved by the Connecticut Public Utilities Regulatory Authority. In order to calculate a total bill, the Supply Charge (also known as the Purchased Gas Adjustment) would need to be included in addition to the Delivery Service Charges listed below. The Supply Charge is established monthly in accordance with and pursuant to the Purchased Gas Adjustment Clause as approved by the Public Utilities Regulatory Authority. The rates are listed on both the Yankee Gas dba Eversource Energy and the Public Utilities Regulatory Authority websites.

10 – Small General Firm Service

This rate is for small-sized commercial or industrial customers with actual or expected annual natural gas usage of up to 5,000 Ccf. Usage up to 200 Ccf of natural gas per month is billed at one rate, and all other usage beyond 200 Ccf per month is billed at a lower rate. All commercial and industrial customers have a Demand Charge on their bill which takes into account individual customer peak demands – or what is required by Eversource Energy's distribution system to service them. In addition, the customer is billed a demand based rate called the Sales Services Demand Charge (or referred to as the Transportation Services Demand Charge, if the customer chooses a third party supplier for their gas supply) which recovers gas supply-related costs associated with Yankee Gas dba Eversource Energy's Liquefied Natural Gas ("LNG") facility. Customers on this rate have the option of having a telemetering device (Daily Demand Meter) for a monthly fee of \$22.00.

NOTE: Customers that elect Operator Gas Supply Service are subject to the TSC Shifted Cost charge of \$0.0685 per Ccf.

20 – Medium General Firm Service

This rate is for medium-sized commercial or industrial customers with an actual or expected annual natural gas usage that is greater than 5,000 Ccf, but less than or equal to 20,000 Ccf. Usage up to 1,000 Ccf of natural gas per month is billed at one rate, and all other usage beyond 1,000 Ccf per month is billed at a lower rate. All commercial and industrial customers have a Demand Charge on their bill which takes into account individual customer peak demands – or what is required by Eversource Energy's distribution system to service them. In addition, the customer is billed a demand based rate called the Sales Services Demand Charge (or referred to as the Transportation Services Demand Charge, if the customer chooses a third party supplier for their gas supply) which recovers gas supply-related costs associated with Yankee Gas dba Eversource Energy's Liquefied Natural Gas ("LNG") facility. Customers on this rate are required to have a telemetering device (Daily Demand Meter) for a monthly fee of \$22.00. NOTE: Customers that elect Operator Gas Supply Service are subject to the TSC Shifted Cost charge of \$0.0685 per Ccf.

30 – Large General Firm Service

This rate is for large-sized commercial or industrial customers with actual or expected annual consumption of greater than 20,000 Ccf. Usage up to 2,500 Ccf of natural gas per month is billed at one rate, and all other usage beyond 2,500 Ccf per month is billed at a lower rate. All commercial and industrial customers have a Demand Charge on their bill which takes into account individual customer peak demands – or what is required by Eversource Energy's distribution system to service them.

In addition, the customer is billed a demand based rate called the Sales Services Demand Charge (or referred to as the Transportation Services Demand Charge, if the customer chooses a third party supplier for their gas supply) which recovers gas supply-related costs associated with Yankee Gas dba Eversource Energy's Liquefied Natural Gas ("LNG") facility. Customers on this rate are required to have a telemetering device (Daily Demand Meter) for a monthly fee of \$22.00. NOTE: Customers that elect Operator Gas Supply Service are subject to the TSC Shifted Cost charge of \$0.0685 per Ccf.

10-SE – Small General Firm Service - System Expansion

This rate is for new service provided to small-sized commercial or industrial customers as of January 1, 2014. Customers on this rate have an actual or expected annual natural gas usage of up to 5,000 Ccf. Usage up to 200 Ccf of natural gas per month is billed at one rate, and all other usage beyond 200 Ccf per month is billed at a lower rate. All commercial and industrial customers have a Demand Charge on their bill which takes into account individual customer peak demands – or what is required by Eversource Energy's distribution system to service them. In addition, the customer is billed a demand based rate called the Sales Services Demand Charge (or referred to as the Transportation Services Demand Charge, if the customer chooses a third party supplier for their gas supply) which recovers gas supply-related costs associated with Yankee Gas dba Eversource Energy's Liquefied Natural Gas ("LNG") facility. Customers on this rate have the option of having a telemetering device (Daily Demand Meter) for a monthly fee. NOTE: Customers that elect Operator Gas Supply Service are subject to the TSC Shifted Cost charge of \$0.0685 per Ccf.

20-SE – Medium General Firm Service - System Expansion

This rate is for new service provided to medium-sized commercial or industrial customers as of January 1, 2014. Customers on this rate have an actual or expected annual natural gas usage that is greater than 5,000 Ccf, but less than or equal to 20,000

Ccf. Usage up to 1,000 Ccf of natural gas per month is billed at one rate, and all other usage beyond 1,000 Ccf per month is billed at a lower rate. All commercial and industrial customers have a Demand Charge on their bill which takes into account individual customer peak demands – or what is required by Eversource Energy's distribution system to service them. In addition, the customer is billed a demand based rate called the Sales Services Demand Charge (or referred to as the Transportation Services Demand Charge, if the customer chooses a third party supplier for their gas supply) which recovers gas supply-related costs associated with Yankee Gas dba Eversource Energy's Liquefied Natural Gas ("LNG") facility. Customers on this rate are required to have a telemetering device (Daily Demand Meter) for a monthly fee. NOTE: Customers that elect Operator Gas Supply Service are subject to the TSC Shifted Cost charge of \$0.0685 per Ccf.

30-SE – Large General Firm Service - System Expansion

Customers on this rate have an actual or expected annual consumption of greater than 20,000 Ccf. Usage up to 2,500 Ccf of natural gas per month is billed at one rate, and all other usage beyond 2,500 Ccf per month is billed at a lower rate. All commercial and industrial customers have a Demand Charge on their bill which takes into account individual customer peak demands – or what is required by Eversource Energy's distribution system to service them. In addition, the customer is billed a demand based rate called the Sales Services Demand Charge (or referred to as the Transportation Services Demand Charge, if the customer chooses a third party supplier for their gas supply) which recovers gas supply-related costs associated with Yankee Gas dba Eversource Energy's Liquefied Natural Gas ("LNG") facility. Customers on this rate are required to have a telemetering device (Daily Demand Meter) for a monthly fee. NOTE: Customers that elect Operator Gas Supply Service are subject to the TSC Shifted Cost charge of \$0.0685 per Ccf.
