

Summary of Residential Gas Rates (CT)

Last Updated: April 1, 2020

The following rates are available to customers and have been approved by the Connecticut Public Utilities Regulatory Authority. In order to calculate a total bill, the Supply Charge (also known as the Purchased Gas Adjustment) would need to be included in addition to the Delivery Service Charges listed below. The Supply Charge is established monthly in accordance with and pursuant to the Purchased Gas Adjustment Clause as approved by the Public Utilities Regulatory Authority. The rates are listed on both the Yankee Gas dba Eversource Energy and the Public Utilities Regulatory Authority websites.

01 – Residential Non-Heating Service

This rate is for all single family residential dwellings, and multi-family residential dwellings serving five or less units from a single meter, where the use of natural gas is for purposes other than space heating (i.e. water heating, cooking, fireplace, etc.).

- Delivery Charge (per Ccf): \$1.6175

02 – Residential Heating Firm Service

This rate is for all single family residential dwellings, and multi-family residential dwellings serving five or less units from a single meter, that use natural gas for space heating.

- Delivery Charge (per Ccf)
 - First 30 Ccf: \$0.8587
 - All over 30 Ccf: \$0.6126

03 – Residential Multi-Dwelling Firm Service

This rate is for property owners of all multi-dwellings with six or more units served through a single meter. Rate 03 customers have a Demand Charge on their bill which takes into account individual customer peak demands – or what is required by Yankee Gas dba Eversource Energy's distribution system to serve them. In addition, the customer is billed a demand based rate called the Sales Services Demand Charge (or referred to as the Transportation Services Demand Charge, if the customer chooses third party supplier for their gas supply) which recovers gas supply-related costs associated with Yankee Gas dba Eversource Energy's Liquefied Natural Gas ("LNG") facility. Customers on this rate have the option of having a telemetering device (Daily Demand Meter) for a monthly fee of \$21.50. NOTE: Customers that elect Operator Gas Supply Service are subject to the TSC Shifted Cost charge of \$0.0719 per Ccf.

- Delivery Charge (per Ccf)
 - First 1,000 Ccf: \$0.2793

- SER Mechanism Charge (per Ccf of billing demand): \$0.0705
- GSI Charge (per Ccf): \$0.0280
- Revenue Adjustment Mechanism (per Ccf): -\$0.0010
- CAM Charge (per Ccf): \$0.0460
- Sales Services Demand Charge (per Ccf of billing demand): \$0.4512

02-SE - Residential Heating Firm Service - System Expansion

This rate is applicable to new service installations on or after January 1, 2014 for all single family residential dwellings, and multi-family residential dwellings serving five or less units from a single meter, that use natural gas for space heating.

Below are the current Rate 02-SE rates for an "on main" and "off main" customers. An "on main" customer is defined as a customer who has an existing main that is directly in front of their premises as of December 31, 2013. An "off main" customer is a customer whose service required the addition of a main in the street after December 31, 2013.

03-SE - Residential Multi-Dwelling Firm Service - System Expansion

This rate is applicable for new service provided to property owners of all multi-family dwellings with six or more units served through a single meter as of January 1, 2014. Rate 03-SE customers have a Demand Charge on their bill which takes into account individual customer peak demands – or what is required by Yankee Gas dba Eversource Energy's distribution system to serve them. In addition, the customer is billed a demand based rate called the Sales Services Demand Charge (or referred to as the Transportation Services Demand Charge, if the customer chooses third party supplier for their gas supply) which recovers gas supply-related costs associated with Yankee Gas dba Eversource Energy's Liquefied Natural Gas ("LNG") facility. Customers on this rate have the option of having a telemetering device (Daily Demand Meter) for a monthly fee. NOTE: Customers that elect Operator Gas Supply Service are subject to the TSC Shifted Cost charge of \$0.0719 per Ccf.

Below are the current Rate 03-SE rates for "on main" and "off main" customers. An "on main" customer is defined as a customer who has an existing main that is directly in front of their premises as of December 31, 2013. An "off main" customer is defined as a customer whose service required the addition of a main in the street after December 31, 2013.
