**RESIDENTIAL HEATING FIRM SERVICE – SYSTEM EXPANSION**

**AVAILABILITY:** This rate is applicable to new service installations on or after January 1, 2014 for all single family residential dwellings, and multi-family residential dwellings serving five or less units from a single meter, and use natural gas for space heating, and where distribution facilities are suitable for service requested.

**DEFINITIONS:**

On Main Customer – Defined as a Customer who has an existing main that is directly in front of their premises as of December 31, 2013.

Off Main Customer – Defined as a Customer whose service required an addition of a main in the street after December 31, 2013.

Certain charges under this rate schedule shall apply based on whether the Customer is defined as On Main or Off Main.

**MEASUREMENT REQUIREMENT:** Monthly billing volumes will be based on cycle meter readings.

**DELIVERY SERVICE:** All Customers served under this rate are considered Company delivery Customers. As such, the following shall apply:

Subject to the Conservation Adjustment Mechanism (CAM) as approved by the Public Utilities Regulatory Authority (“the Authority”).

**Minimum Monthly Delivery Charge:** The minimum charge shall be the Customer Service Charge.

**COMMODITY SERVICE:** All Customers served under this rate are Company commodity Customers. As such, the following shall apply:

Sales Services Charge:	\$0.0707 per Ccf	\$0.0836 per Ccf
Supply Charge:	Established monthly in accordance with and pursuant to the Purchased Gas Adjustment Clause as approved by the Authority and available on its website.	

**Minimum Monthly Commodity Charge:** There is no minimum charge.

**TERM OF SERVICE:** The service as defined begins 10 years from date of initial service at Customer’s service location. This term remains with the premise regardless of account ownership until the 10 year term is completed. Thereafter, Customer will be served under Rate 02 or other applicable rate.
