NOTICE OF FILING, PUBLIC HEARING, AND PROCEDURAL CONFERENCE

D.P.U. 20-130 January 29, 2021

Petition of NSTAR Electric Company d/b/a Eversource Energy for approval of its annual storm cost recovery adjustment factor.

On October 30, 2020, NSTAR Electric Company d/b/a Eversource Energy ("Company") filed a petition with the Department of Public Utilities ("Department") seeking approval of the Company's storm cost recovery adjustment factor ("SCRAF") for effect January 1, 2021. This filing was made pursuant to NSTAR Electric Company and Western Massachusetts Electric Company, D.P.U. 17-05 (2017), NSTAR Electric Company, D.P.U. 18-101 (2018), and the Company's SCRAF tariffs, M.D.P.U. Nos. 63D and 64C. The Department docketed this matter as D.P.U. 20-130.

The Company's SCRAF tariffs provide a mechanism to adjust rates to allow for the annual recovery of eligible incremental costs associated with storm response and restoration. In its filing, the Company presents three components of its SCRAF rate calculations: (1) the Eastern Massachusetts rate calculations whereby the Company proposes to recover in calendar year 2021 approximately \$28.5 million associated with 17 storm events which occurred prior to February 1, 2018; (2) the Western Massachusetts rate calculation in which the Company has closed the storm cost adjustment for 2020 and proposes to reconcile the SCRAF for any over- or under-recovery of costs for storm events prior to February 1, 2018; and (3) the Consolidated Massachusetts rate calculation whereby the Company proposes to recover in calendar year 2021 approximately \$20.3 million in costs associated with three storm events collectively referred to as the March 2018 Nor'easter. The costs associated with the 17 storm events in Eastern Massachusetts were approved in NSTAR Electric Company, D.P.U. 16-74 (February 6, 2020); NSTAR Electric Company, D.P.U. 17-51 (February 6, 2020); and NSTAR Electric Company, D.P.U. 18-125 (December 12, 2020). The storms costs associated with the March 2018 Nor'easter are the subject of ongoing investigation in D.P.U. 18-125.

On December 21, 2020, the Department approved the Company's SCRAF filing, subject to further investigation and reconciliation. <u>NSTAR Electric Company</u>, D.P.U. 20-130. In this phase of the proceeding, the Department will investigate whether the SCRAFs currently in effect includes only those costs that are allowed pursuant to the SCRAF tariffs and the Department decisions referenced above.

Due to the COVID-19 state of emergency issued by Governor Baker on March 10, 2020, and certain ongoing restrictions and safety measures relating to in-person events, the Department will conduct a virtual public hearing to receive comments on the Company's petition, immediately followed by a procedural conference. Alternatively, any person interested in commenting on this matter may submit electronic written comments no later than the close of business (5:00 p.m.) on **March 3**, **2021**. At this time, all filings must be submitted only in electronic format in recognition of the difficulty that parties and the Department may have filing and receiving original copies due to the ongoing state of emergency (please see further filing instructions below).

Any person who desires to participate in the evidentiary phase of this proceeding shall file a petition for leave to intervene no later than 5:00 p.m. on March 1, 2021. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions to intervene must be filed by the close of business (5:00 p.m.) on the second business day after the petition to intervene was filed.

All documents submitted to the Department pursuant to this Notice must be submitted in **pdf format** by e-mail attachment to dpu.efiling@mass.gov and tina.chin@mass.gov. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 20-130); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. All documents submitted in electronic format will be posted on the Department's website as soon as practicable at http://www.mass.gov/dpu. Importantly, all large files submitted must be broken down into electronic files that do not exceed 20 MB.
