## NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 22-GREC-05 May 19, 2022

Petition of Eversource Gas Company of Massachusetts d/b/a Eversource Energy, pursuant to G.L. c. 164, § 145, for Approval of the Reconciliation of its 2021 Gas System Enhancement Plan and Review and Approval of its Gas System Enhancement Reconciliation Adjustment Factors.

On April 29, 2022, and May 17, 2022, Eversource Gas Company of Massachusetts d/b/a Eversource Energy ("EGMA" or "Company") submitted to the Department of Public Utilities ("Department") a reconciliation of its 2021 gas system enhancement plan ("GSEP") to replace aging natural gas pipeline infrastructure. Based on the Company's calculations, it proposes to collect \$8,140,474 from ratepayers as under-recoveries through the gas system enhancement reconciliation adjustment factors ("GSERAFs"). The Company's reconciliation filing does not include any projects or costs associated with work completed or undertaken as a result of the September 18, 2018 Merrimack Valley incident. The Department has docketed this matter as D.P.U. 22-GREC-05.

The Company proposes the following GSERAFs by rate class sector for effect November 1, 2022:

Rate Class Sector	Proposed GSERAF (\$/Therm)
Residential	\$0.0184
Low Annual Use Commercial and Industrial (C&I)	\$0.0199
Medium Annual Use C&I	\$0.0116
High Annual Use C&I	\$0.0103
Extra High Annual Use C&I	\$0.0082

The Company states that approval of the GSERAFs will result in an average monthly bill increase of \$1.71, or 0.69 percent, for the average residential heating customer using 132 therms

per month during winter months, and an average monthly bill increase of \$0.37, or 0.58 percent, for the average residential heating customer using 29 therms per month during summer months.

The Department is providing an extended written comment period and any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on Thursday, June 23, 2022. If, however, a member of the public is unable to send written comments by email, a paper copy may be sent to Mark D. Marini, Secretary, Department of Public Utilities, One South Station, 5th Floor, Boston, Massachusetts, 02110.

Any person who desires to participate in the evidentiary phase of this proceeding must file a written petition for leave to intervene with the Department not later than the close of business (5:00 p.m.) on Monday, June 6, 2022. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. All petitions for leave to intervene must be submitted by email only to <a href="mailto:dpu.efiling@mass.gov">dpu.efiling@mass.gov</a>, carol.pieper@mass.gov, and the Company's attorney at <a href="dwinter@keeganwerlin.com">dwinter@keeganwerlin.com</a>. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions to intervene must be filed by email by the close of business (5:00 p.m.) on the second business day after the petition to intervene was filed. The Attorney General of the Commonwealth of Massachusetts filed a notice to intervene in this matter pursuant to G.L. c. 12, § 11E(a).

Documents provided to the Department must specify: (1) the docket number of the proceeding (D.P.U. 22-GREC-05); (2) the name of the person or company submitting the filing; (3) a brief descriptive title of the document; and (4) the name, title, email address, and telephone number of a person to contact in the event of questions about the filing.
