Loan Deferral Request & Attestation**

By signing below, I/We agree and attest to the following terms and conditions:

- 1.) As a result of the National Emergency declared by the President of the United States on March 13, 2020, in response to the novel coronavirus disease 2019 (COVID-19) pandemic in the United States and the State of Emergency declared by the Governor of Massachusetts on March 10, 2020 and subsequent Executive Orders pertaining thereto, I/We hereby request that the monthly payments on my Eversource Energy Small Business Energy Efficiency loan be deferred for (choose/circle): (one) (two) (three) months (maximum 3 months).
