Previous Small ZREC Results

Year 1 Small ZREC (Closed December 4, 2013)

The Eversource Year 1 Small ZREC Tariff Rate was \$164.22/REC.

The Year 1 Small ZREC Tariff Program opened at 12:00 pm (noon), on January 8, 2013. The two-week window (as described in the posted Rules and Process for Submitting Applications for the Small ZREC Tariff) ended as of 12:00 PM Eastern Prevailing Time (EPT) (noon) on Tuesday, January 22, 2013.

At the close of the Year 1 Small ZREC 2-week window on January 22, 2013, Eversource received 479 completed Year 1 Small ZREC Applications, which totaled over \$5.6M in requested Year 1 Small ZREC funding - more than 138% above Eversource's available Year 1 Small ZREC budget of \$2.36M. Therefore, based on the volume of applications received during the two-week window, Eversource conducted a random selection process of completed Applications submitted during the 2-week window, which was observed by a representative of the State of Connecticut Office of Consumer Counsel (OCC). The random selection process resulted in a numerical rank of all completed Applications received during the two-week window.

To determine your completed Year 1 Small ZREC Application's position in the numerical rank, Applicants should look for their project's "queue" position by Application ID number. Applicants received their Application ID number in the confirmation email that was sent upon successful submittal of a Small ZREC Application. At the close of the Year 1 Small ZREC, on December 4, 2013, Eversource selected 253 Applications, of which 210 have active service agreements. The Small ZREC Budget of \$2.36M was committed with only \$10,778 remaining. The remaining \$10,778 will be rolled over to the Year 2 Small ZREC Program.

Pursuant to Section 1.8 of the Rules and Process for Submitting Applications for the Small ZREC Tariff, the Applications that were in the standby queue expired on December 4, 2013. All non-selected Applicants will need to apply to the Year 2 Small ZREC program to be considered for a Year 2 Small ZREC Service Agreement. There is no preference or advantage offered to non-selected applications from the Year 1 Small ZREC queue.

Year 2 Small ZREC (Closed September 30, 2014)

The Eversource Year 2 Small ZREC Tariff Rate was \$103.01/REC.

The Year 2 Small ZREC Tariff Program opened at 1:00 p.m., on February 14, 2014. The two-week window (as described in the posted Rules and Process for Submitting Applications for the Small ZREC Tariff) ended as of 1:00 p.m. Eastern Prevailing Time (EPT) on February 28, 2014.

At the close of the Year 2 Small ZREC two-week window on February 28, 2014, Eversource received 460 completed Year 2 Small ZREC Applications, which totaled over \$3.76M in requested Year 2 Small ZREC funding - more than 74% above Eversource's available Year 2 Small ZREC budget of \$2.16M. Therefore, based on the volume of applications received during the two-week window, Eversource conducted a random selection process of completed Applications submitted during the two-week window, which was observed by a representative of the State of Connecticut Office of Consumer Counsel (OCC). The random selection process resulted in a numerical rank of all completed Applications received during the two-week window.

To determine your completed Small ZREC Application's position in the numerical rank, Applicants should look for their project's "queue" position by Application ID number. At the close of the Year 2 Small ZREC, on September 30, 2014, Eversource selected 353 Applications, of which 275 have active service agreements. The Small ZREC Budget of \$2.16M was committed with only \$5,128 remaining. The remaining \$5,128 will be rolled over to the Year 3 Small ZREC Program.

Pursuant to Section 1.8 of the Rules and Process for Submitting Applications for the Small ZREC Tariff, the Applications that were in the standby queue expired on September 30, 2014. All non-selected Applicants will need to apply to the Year 3 Small ZREC program to be considered for a Year 3 Small ZREC Service Agreement. There is no preference or advantage offered to non-selected applications from the Year 2 Small ZREC queue.

Year 3 Small ZREC (Closed January 7, 2016)

The Eversource Year 3 Small ZREC Tariff Rate was \$80.97/REC.

The Year 3 Small ZREC Tariff Program opened at 1:00 p.m. on February 13, 2015. The two-week window (as described in the posted Rules and Process for Submitting Applications for the Small ZREC Tariff) ended as of 1:00 p.m. Eastern Prevailing Time (EPT) on Friday, February 27, 2015.

At the close of the Year 3 Small ZREC two-week window on February 27, 2015, Eversource received 411 completed Year 3 Small ZREC Applications, leaving the Eversource Year 3 Small ZREC budget of \$2.67M less than 10 percent oversubscribed. Therefore, based on the volume of applications received during the two-week window, Eversource conducted a random selection process of completed Applications submitted during the two-week window, which was observed by a representative of the State of Connecticut Office of Consumer Counsel (OCC). The random selection process resulted in a numerical rank of all completed Applications received during the two-week window.

To determine your completed Small ZREC Application's position in the numerical rank, Applicants should look for their project's "queue" position by Application ID number. At the close of the Year 3 Small ZREC, on January 7, 2016, Eversource selected 519 Applications, of which 402 have active service agreements. The Small ZREC Budget of \$2.67M was committed with only \$7,463 remaining. The remaining \$7,463 will be rolled over to the Year 4 Small ZREC Program.

Pursuant to Section 1.8 of the Rules and Process for Submitting Applications for the Small ZREC Tariff, the Applications that were in the standby queue expired on January 7, 2016. All non-selected Applicants will need to apply to the Year 4 Small ZREC program to be considered for a Year 4 Small ZREC Service Agreement. There is no preference or advantage offered to non-selected applications from the Year 3 Small ZREC queue.

*****NOTE:** There is one key change to the Year 4 Small ZREC application process that Eversource would like to make potential applicants aware of:

Pursuant to Section 2(f) of Public Act 15-194, "Any customer of an Electric Distribution Company that is eligible for the residential solar investment program shall not be eligible for small zero-emission renewable energy credits pursuant to section 16-244s."

WHAT THIS MEANS FOR APPLICANTS:

- 1. If your project qualifies for the Connecticut Green Bank's Residential Solar Investment Program, it no longer qualifies for the Small ZREC program.**
- 2. All residential applicants will be required to submit a copy of the "Incentive Application Denied" letter issued by the Connecticut Green Bank as an attachment to their Year 4 Small ZREC application. Therefore, if your Small ZREC project is or will be at a residential site (Eversource Electric rates 1, 5, or 7), you must first apply to the Connecticut Green Bank, and if denied, you must provide a PDF copy of your "Incentive Application Denied" letter as a required attachment during step 6/6 in the application process. Year 4 Small ZREC (Closed November 18, 2016)

The Eversource Year 4 Small ZREC Tariff Rate was \$82.58/REC.

The Year 4 Small ZREC Tariff Program opened at 1:00 p.m. on February 12, 2016. The two-week window (as described in the posted Rules and Process for Submitting Applications for the Small ZREC Tariff) ended as of 1:00 p.m. Eastern Prevailing Time (EPT) on Friday, February 26, 2016.

At the close of the Year 4 Small ZREC two-week window on February 26, 2016, Eversource received 261 completed Year 4 Small ZREC applications, leaving the Eversource Year 4 Small ZREC budget of \$3.28 million under-subscribed by approximately 50 percent. Because we were under-subscribed, Eversource did not need to conduct a random selection.

At the close of the Year 4 Small ZREC, on November 18, 2016, Eversource selected 429 Applications, of which 312 have active service agreements. The Small ZREC Budget of \$3.28M was committed with \$1.41M remaining. The remaining \$1.44M will be rolled over to the Year 5 Small ZREC Program.

Pursuant to Section 1.8 of the Rules and Process for Submitting Applications for the Small ZREC Tariff, the Applications that were in the standby queue expired on November 18, 2016. All non-selected Applicants will need to apply to the Year 5 Small ZREC program to be considered for a Year 5 Small ZREC Service Agreement. There is no preference or advantage offered to non-selected applications from the Year 4 Small ZREC queue.

Year 5 Small ZREC (Closed January 11, 2018)

The Eversource Year 5 Small ZREC Tariff Rate was \$103.07/REC.

The Year 5 Small ZREC Tariff Program opened at 1:00 p.m. on February 15, 2017. The two-week window (as described in the posted Rules and Process for Submitting Applications for the Small ZREC Tariff) ended as of 1:00 p.m. Eastern Prevailing Time (EPT) on March 1, 2017.

At the close of the Year 5 Small ZREC two-week window on March 1, 2017, Eversource received 282 completed Year 5 Small ZREC applications, leaving the Eversource Year 5 Small ZREC budget of \$4 million under-subscribed by approximately 40 percent. Because we were under-subscribed, Eversource did not need to conduct a random selection.

At the close of the Year 5 Small ZREC on January 11, 2018, Eversource selected 562 Applications, of which 427 have active service agreements. The Small ZREC Budget of \$4M was committed with \$147,577 remaining. The remaining funds will be rolled over to the Year 6 Small ZREC Program.

Pursuant to Section 1.8 of the Rules and Process for Submitting Applications for the Small ZREC Tariff, the Applications that were in the standby queue expired on January 11, 2018. All non-selected Applicants will need to apply to the Year 6 Small ZREC program to be considered for a Year 6 Small ZREC Service Agreement. There is no preference or advantage offered to non-selected applications from the Year 5 Small ZREC queue.

Year 6 Small ZREC (Closed February 22, 2019)

The Eversource Year 6 Small ZREC Tariff Rate was \$99.42/REC.

The Year 6 Small ZREC Tariff Program opened at 1:00 p.m. on March 6, 2018. The two-week window (as described in the posted Rules and Process for Submitting Applications for the Small ZREC Tariff) ended as of 1:00 p.m. Eastern Prevailing Time (EPT) on March 20, 2018.

At the close of the Year 6 Small ZREC two-week window on March 20, 2018, Eversource received 172 completed Year 6 Small ZREC applications, leaving the Eversource Year 6 Small ZREC budget of approximately \$3 million under-subscribed by approximately 46 percent. Because we were under-subscribed, Eversource did not need to conduct a random selection.

At the close of the Year 6 Small ZREC on February 22, 2019, Eversource selected 417 Applications, of which 314 have active service agreements. The Small ZREC Budget of \$3M was committed with \$285,860.54 remaining. The remaining funds will be rolled over to the Year 7 Small ZREC Program.

Pursuant to Section 1.8 of the Rules and Process for Submitting Applications for the Small ZREC Tariff, the Applications that were in the standby queue expired on February 22, 2019. All non-selected Applicants will need to apply to the Year 7 Small ZREC program to be considered for a Year 7 Small ZREC Service Agreement. There is no preference or advantage offered to non-selected applications from the Year 6 Small ZREC queue.

Year 7 Small ZREC (Closed December 4, 2020)

The Eversource Year 7 Small ZREC Tariff Rate was \$100.74/REC.

The Year 7 Small ZREC Tariff Program, which was a combination of the Years 7 and 8 small ZREC programs, opened at 1:00 p.m. on April 1, 2019. The two-week window (as described in the posted Rules and Process for Submitting Applications for the Small ZREC Tariff) ended as of 1:00 p.m. Eastern Prevailing Time (EPT) on April 15, 2019.

At the close of the Year 7 Small ZREC two-week window on April 15, 2019, Eversource received 118 completed Year 7 Small ZREC applications, leaving the Eversource Year 7 Small ZREC budget of approximately \$4.9 million under-subscribed by approximately 70 percent. Because we were under-subscribed, Eversource did not need to conduct a random selection.

At the close of the Year 7 Small ZREC on December 4, 2020, Eversource selected 571 Applications, of which 428 have active service agreements. The Small ZREC Budget of \$4.9M was committed with \$754,068.54 remaining. The remaining funds will be rolled over to the Year 9/10 Small ZREC Program.

Pursuant to Section 1.8 of the Rules and Process for Submitting Applications for the Small ZREC Tariff, the Applications that were in the standby queue expired on December 4, 2020. All non-selected Applicants will need to apply to the Year 9/10 Small ZREC program to be considered for a Year 9/10 Small ZREC Service Agreement. There is no preference or advantage offered to non-selected applications from the Year 7 Small ZREC queue.
