# **Previous LREC/ZREC RFP Results**

Copies of the specific contracts associated with these RFP's are on file with the Public Utilities Regulatory Authority (PURA). #### **Year 1 RFP Results**

Eversource and UI jointly issued the first RFP on May 1, 2012, and on October 10, 2012, Eversource filed the results of the RFP with PURA. On November 21, 2012, PURA approved, in part, Eversource's Procurement Plan. Specifically, the 76 selected LREC and ZREC contracts that were submitted in the Procurement Plan were approved. In an effort to utilize the remaining LREC budget that was not committed prior to the initial filing of the Procurement Plan, Eversource selected four additional bids from the queue of remaining LREC bids that had chosen to honor their bids, and filed an Updated LREC/ZREC Procurement Plan with PURA on January 18, 2013. PURA approved the Updated Procurement Plan on February 1, 2013, which brought a close to the first year of the Procurement Process.

#### **Year 2 RFP Results**

Eversource and UI jointly issued the second RFP on April 25, 2013. On October 22, 2013, PURA approved Eversource's Interim Procurement Plan. Specifically, the 90 selected LREC and ZREC contracts that were submitted in the Interim Procurement Plan were approved. In order to utilize the remaining LREC/ZREC budget that was not committed prior to the interim filing of the Procurement Plan, Eversource selected 15 additional bids from the queue of remaining bids, and filed a Final Year 2 LREC/ZREC Procurement Plan with PURA on December 4, 2013, which included an additional 15 LREC and ZREC contracts, bringing the total of the Year 2 LREC/ZREC contracts to 105. PURA approved the Final Year 2 Procurement Plan on January 16, 2014, which brought a close to the second year of the Procurement Process.

# **Year 3 RFP Results**

Eversource and UI jointly issued the third RFP on April 24, 2014. On September 23, 2014, PURA approved Eversource's Interim Procurement Plan, which consisted of 131 selected LREC and ZREC contracts. On December 8, 2014, PURA approved Eversource's Supplement to the Interim Procurement Plan, which consisted of 8 additional selected LREC and ZREC contracts. On December 30, 2014, Eversource filed its Final Year 3 LREC/ZREC Procurement Plan with PURA, which included an additional 12 selected projects. PURA approved the Final Year 3 Procurement Plan on January 14, 2015, which brings a close to the third year of the Procurement Process, with a total of 151 approved contracts.

#### **Year 4 RFP Results**

Eversource and UI jointly issued the fourth RFP on April 30, 2015. On December 11, 2015, PURA approved Eversource's Interim Procurement Plan, which consisted of 158 selected LREC and ZREC contracts, and on December 28, 2015, PURA approved the 158 selected LREC and ZREC contracts filed in the Interim Procurement Plan. On February 22, 2016, Eversource filed its Final Year 4 LREC/ZREC Procurement Plan with PURA, which included an additional 9 selected projects. PURA approved the Final Year 4 Procurement Plan on April 1, 2016, which brings a close to the fourth year of the Procurement Process, with a total of 167 approved contracts.

#### **Year 5 RFP Results**

Eversource and UI jointly issued the fifth RFP on April 28, 2016. On November 10, 2016, PURA approved Eversource's Interim Procurement Plan. Specifically, the 112¹ selected LREC and ZREC contracts that were submitted in the Interim Procurement Plan were approved. On December 19, 2016, Eversource filed its Final Year 5 LREC/ZREC Procurement Plan with PURA, which included an additional 7 selected projects. PURA approved the Final Year 5 Procurement Plan on February 28, 2017, which brings to a close the fifth year of the Procurement Process, with a total of 118 approved contracts.

# **Year 6 April RFP Results**

Eversource and UI jointly issued the year 6 April RFP on April 27, 2017. Pursuant to PURA's ruling on Motion No. 86 in Docket 11-12-06, the Companies conducted two rounds of selection in the April RFP. On August 31, 2017, Eversource filed the Year 6 Interim Procurement Plan, which consisted of 77 selected LREC and ZREC contracts as a result of the April RFP. PURA approved the Year 6 Interim Procurement Plan on September 11, 2018.

#### **Year 6 Fall RFP Results**

Eversource and UI jointly issued the year 6 Fall RFP on September 25, 2017. On February 28, 2018, Eversource filed the Year 6 Final Procurement Plan, which consisted of 74 selected LREC and ZREC contracts as a result of the Fall RFP. The Final Procurement Plan was approved on May 14, 2018, which brings to a close the sixth year of the Procurement Process, with a total of 151 approved contracts.

## **Year 7 RFP Results**

Eversource and UI jointly issued the seventh RFP on August 9, 2018. On February 22, 2019, Eversource filed its Final Year 7 LREC/ZREC Procurement Plan with PURA, which included a total of 139 selected projects. PURA approved the Final Year 7 Procurement Plan on May 13, 2019, which brings to a close the seventh year of the Procurement Process, with a total of 139 approved contracts.

### **Year 8 RFP Results**

Eversource and UI jointly issued the eighth RFP on April 30, 2019. On October 25, 2019, Eversource filed its Final Year 8 LREC/ZREC Procurement Plan with PURA, which included a total of 101 selected projects. PURA approved the Final Year 8 Procurement Plan on October 29, 2019, which brings to a close the eighth year of the Procurement Process, with a total of 101 approved contracts.

# **Year 9 RFP Results**

Eversource and UI jointly issued the ninth RFP on April 30, 2020. On December 10, 2020, Eversource filed its Final Year 9 LREC/ZREC Procurement Plan with PURA, which included a total of 101 selected projects. PURA approved the Final Year 9 Procurement Plan on January 22, 2021, which brings to a close the ninth year of the Procurement Process, with a total of 101 approved contracts.
